

SCHENGEN INDIVIDUAL VISA REQUIREMENTS

GENERAL REQUIREMENTS

- 1. Duly accomplished and signed Schengen Visa Application Form (MPQ will assist)
- 2. 2 pcs Passport size picture (white background)
- 3. Original Old and New Passport (with all old visa copies and stamps)
- 4. Bank Certificate (current with 300k peso up fund)
- 5. Bank Statements (*issued within 6 months*) indicate the ff: Account opening date, type of account, average daily balance and to-ate/current balance
- 6. PSA Birth Certificate
- 7. PSA Marriage Certificate
- 8. Any Valid ID's
- 9. PRC ID for professional (Doctors, Engineers, Accountants, etc)
- 10. IBP ID (for lawyers)
- 11. Proof of ties in the Philippines (Land Title, ORCR vehicle, etc)

If the Applicant is a STUDENT

- 12. Certificate of Enrolment/Registration
- 13. School ID
- 14. Affidavit of Support
- 15. Guarantee Letter
- 16. Financial documents of the supporter, Bank Certificate with fund and Bank statement 6 months

If the Applicant is EMPLOYED

- 17. Certificate of Employment (must include applicant's position, date hired, salary, date of return to work)
- 18. Leave of Absence (indicate the days paid and unpaid)
- 19. 2 Recent Payslips (if applicable)
- 20. Latest Income Tax Return (ITR 2316) with BIR Stamp
- 21. Travel Authority (for Government Employee)
- 22. Company ID (front and back)

If the Applicant have BUSINESS/Business Owners

- 23. DTI/SEC/Mayor's Permit/Business Permit
- 24. Latest Income Tax Return (ITR 1701) with BIR Stamp
- 25. Certificate of Registration
- 26. Income Statement/Cash Flow Statement

If the Company will sponsor the trip

- 27. Affidavit of Support (notarized)
- 28. Company's Bank Certificate & Bank Statements
- 29. Company's Business Documents (SEC/DTI and Business Permit)
- 30. Company's Letter of Invitation

If the Applicant is Senior

31. Senior ID



If the Applicant is Foreigner

- 32. Copy of Alien Certificate of Registration (ACR)
- 33. Copy of International Card Residence (ICR)
- 34. Re-entry permit

If someone is paying your trip/Sponsor

- 35. Affidavit of Support and Letter of Guarantee
- 36. Formal Obligation (from sponsor's country)
- 37. Proof of Relationship between Applicant & Guarantor (e.g. Birth Certificates/Marriage Certificate, etc...)
- 38. Photos Together (if your sponsor is your partner/boyfriend/girlfriend)
- 39. Guarantor's Bank Certificate & Bank Statement (must be issued within 3 months)
- 40. Guarantor's ITR (Form 1701/1702/2316 latest clear copy with BIR Stamp)
