

JAPAN VISA REQUIREMENTS

for VISITING RELATIVES

A. Purpose

Visit relatives residing in Japan **within** the third degree.

B. Requirements

Applicant's Requirements:

- (1) Passport (Holder's signature required)
- (2) Accomplished and signed Application Form
- (3) A facial Photo (4.5 x 3.5 cm)

Note: Submit ALL RELATIVES' Birth Certificate/Marriage Certificate enough to prove the third degree relationship between Applicant and Inviter.

- (4) PSA issued Birth Certificate and Marriage Certificate (for married applicants), issued within 1 year.

Additional Requirements

- If (4) is unreadable, submit Birth/Marriage certificate issued by Local Civil Registrar.
- If Birth Certificate is "LATE REGISTRATION", submit Baptismal Certificate and School Record (Form 137).
- If there is no record of Birth/Marriage in PSA, submit Birth Certificate by Local Civil Registrar and Negative Certificate issued by PSA.

(5) Employment Certificate/Certificate of Membership (if applicant is **self employed**, submit a Certificate of Business Registration.)

- (6) Signed Authorization Letter (MPQ Travel & Tours will provide)

In case that applicant will shoulder part/ all of travel expense,

- (7) Bank Certificate with 6 months ADB
- (8) Photocopy of Income Tax Return (BIR Form)

Inviter's Requirements (From Japan)

- (9) Invitation Letter
- (10) Itinerary in Japan
- (11) Residence Certificate (Jumin-hyo) of Inviter and Guarantor

***Jumin-hyo must describe all household members, without omission of description, except individual Number and Jumin-hyo Code.**

***ADDITIONAL:**

- If inviter or his/her spouse is Japanese, submit his/her Koseki-tohon.
- If inviter/guarantor is not Japanese, submit his/her photocopy of Residence Card (both sides).

In case that guarantor will shoulder part/all of travel expense,

- (12) Guarantee Letter
- (13) Income Certificate (Shotoku-shomeisho)
- (14) Tax Certificate (Nozei-shomeisho, must include description of the total amount of income.)
- (15) Photocopy of Final Tax Return Form (Kakutei-shinkokusyo)
- (16) Bank Certificate
