GUARANTEE LETTER

That I am responsible for his/her Visa renewal and Exit after visa expiration and I will not allow my passenger to take the residence visa with servant profession.

I need to sustain and keep the connection of the said passenger during 27/87 days upon entry/ arrival.

That the office advised and warned me that all passengers under **TOURIST VISA ARE NOT ALLOWED TO WORK**. In this connection, if my passenger caught by the authority working, it is a sole responsibility to answer whatever penalties/fines that the authority will be charged.

I will also guarantee that my guest(s) leaves the country within the legal time limit. In the unlikely event that the guests over stay abscond, I will bear all cost and fines imposed by the Dubai Immigration and I will take full responsibility to pay all fines and penalties if his/her overstay or do not leave the UAE prior to the expiry of the visa. Otherwise, I have to shoulder and take on the obligation to pay the amount of EIGHT THOUSAND FIVE HUNDRED DIRHAMS (8500 AED) for Immigration settlement.

The fines imposed by the Immigration Authorities are as follows: - a penalty will be charged as per the Immigration (if the customer abscond without trace and then appears at a later date for repatriation); cost of repatriation like airline ticket (rate depends on the origin of the guest).

And I understood that the visa fees once applied and paid for in full are non-refundable or non-transferrable, if unutilized due to non-show, rejections or refusals by the immigration due to reasons beyond the control of the travel agency.

This letter is valid until the person who is under our visa exits from UAE or until such time that he/she changes the sponsorship.

Note: As per immigration information, people whose coming for tourist visa and the plan to change status to low category residence (housemaid, driver, painter, cleaner, helper, laborer, cook etc.) they should exit the country and come back. Please do not do the status change from inside, if they did from here the status change without exiting the country, fine will be minimum 50,000 AED.

Please ensure to go out from UAE at least 3 days prior to you visa expiration date to avoid immigration fines & absconding case.

Overstay Passengers are required to pay 340AED for the first (1st) day and 100AED per succeeding days from the date of expiration of your visa to the Department of Immigration.

- All overstay passenger more than 3 days will be subject for absconding and lifetime ban from UAE immigration.**
